Dear Trinity,

As I look back on 2023, I am moved with gratitude. When I wrote my letter for the last annual report, I had been in this community less than a year. As I write now, we are approaching the two year mark in our time together. It has been a blessing to get to know each other, to move out of a season of pandemic change and transition and to feel our shared energy taking tangible shape in what we are doing together in worship, fellowship, and participating in God's mission on campus and far beyond. Last year, our Mission Council went through a discernment process to focus our activities. They identified needs in our community that we might impact together–education, food insecurity, and advocacy. It has been a privilege to see this community mobilize to learn more and to do more to address these needs.

I'm also grateful to say that our church is growing in every age group. We have prioritized intergenerational engagement in the last year and will continue to do so. Both of our Sunday worship services now include regular leadership opportunities for children and youth, and we continue to seek new and creative ways to employ the many talents in our congregation.

Our infrastructure campaign was completed this year and the fruits of that work and careful stewardship have not only caught up our deferred maintenance and refreshed our spaces, but have let us open the Trinity campus to new ways of participating in mission. We have sought deeper understanding and have welcomed our neighbors, hosting such events as a Partners in Ministry luncheon for Columbia Theological Seminary, a Record Restriction Day in partnership with the Fulton County District Attorney's office and the Georgia Justice Project, and the annual Rosemary Kittrell lecture with speaker Arthur Brooks, attended by hundreds of our neighbors committed to loving our enemies in a polarized world.

After a season of much searching, we are close to having a full staff. I continue to be amazed by my colleagues' talents and even more importantly, their willingness to share them. This is a gracious, loving, and devoted team. And as a staff, we continue to be amazed by how much Trinity's members do on a regular basis to ensure that this congregation carries on. You all work and welcome and love so well.

I close this second of my annual report letters with the deepest gratitude to God for all of you and the life we share. Thank you.

From the Clerk of Session

It is truly a wonderful time to be at Trinity. After several years of challenges and transition, 2023 ushered in an era of hope, stability, and enthusiasm for our congregation. All the time and energy previously focused on navigating pandemic protocols, searching for a senior pastor, conducting congregational surveys, and completing capital improvements was finally (and fully) redirected to the joyful work of fellowship, outreach, and mission in 2023. Because of our congregation's perseverance and our senior pastor's leadership, Trinity is certainly stronger today than it was a year ago, and with God's help—we will continue doing the work required to maintain this beautiful campus, support the church's many offerings, and fulfill Trinity's mission in our community.

In terms of membership trends at Trinity, our congregation enjoyed positive growth in 2023. We began the year with 1,598 active members and ended with 1,624 (a net gain of 26 members). Specifically, Trinity welcomed 14 new confirmands (vs. 19 in 2022) and 40 new adult members in 2023 (vs. 28 in 2022). There were also 12 baptisms in 2023 (vs. 10 in 2022) and 14 member deaths (vs. 19 in 2022).

Additionally, Trinity achieved notable administrative and operational successes over the course of 2023.

- Session leadership launched an extensive outreach effort to contact all Trinity members, increase congregational engagement, and review and refine church rolls to ensure accuracy.
- Trinity staff and committee members worked to refine and enhance livestream worship capability and Zoom meeting attendance options that grant individuals flexibility in participation.
- A churchwide infrastructure campaign was successfully completed to provide technology upgrades, signage improvements, and deferred maintenance in the Sanctuary, Williams Hall, Old Fellowship Hall, staff offices, and Building D.
- Thanks to the generosity of many, Trinity's 2023 commitment campaign was a success, and—as a result—all the mission, property, and staffing initiatives the campaign enabled will be fulfilled.

• And, of course, the Nominating Committee's search for Trinity's new Associate Pastor commenced.

Around every (freshly painted) corner, we see the Spirit moving at Trinity Church. As we enter a new year together, let us give thanks for Trinity's vibrant, growing congregation and its talented capable staff. May we never let a Sunday pass without offering gratitude for the bounty of blessings before us: the outstanding worship and music programming, the varied and meaningful adult education offerings, the joyful engagement of children and youth, and the dedication to mission and service beyond our church campus. Surely all the work of 2023 has led us to this good place. Thanks be to God.

As our church is "reformed, always reforming," the great tradition of Adult Education at Trinity continues to grow and evolve. Digital media specialist Phil Hawkins has helped capture, organize, and stream course content on Trinity's YouTube channel, including: classes stemming from Trinity's partnership with the Candler Foundry; a fantastic book discussion course related to the 2023 Kittrell Lecture with Arthur Brooks; and "Presbyterianism 101," taught by Revs. Rebekah LeMon and Lucy Strong.

The Foundations Bible Study and Coffee and Connections classes also fall under the Adult Education umbrella and provide discussion-based courses that preserve time for fellowship for adults of all ages and stages.

Seeking also to "promote engagement with the world all around us," Adult Education has not shied away from offering relevant courses on the unacceptable state of women's healthcare in the United States, God's presence as pertaining to youth sports, and classes that have aimed to break down what guest speaker Dr. Joel Kemp termed "the lie of white supremacy."

The 2023 Rosemary Kittrell lecturer was Dr. Arthur Brooks. Ahead of the lecture, Trinity engaged in book study and conversation about Dr. Brooks' bestseller Love Your Enemies: How Decent People Can Save America from the Culture of Contempt, and on November 16, Dr. Brooks inspired our packed sanctuary to the calling of loving enemy.

Adult Education at Trinity is "like a wheel with spokes," reaching out and back in to engage our community. The committee strives to offer creative, relevant, and challenging learning opportunities that engage meaningful topics and preserve different learning formats.

The committee continues to add members and plan seasonal church school classes 9-12 months in advance. Join adult ed offerings Sundays during the church school hour and be a part of the long-standing Christian ministry of Adult Education at Trinity.

Children & Family

What a year it has been for CFM! 2023 continued the growth in programming, excitement and attendance of our Children's & Family Ministries events. The winter/spring season began with Children's Sunday followed by our annual Shrove Tuesday Pancake race. The Pancake Race was especially well attended this year, as TPC's Session and new member class joined families for this annual event. At the end of Lent, grandparents, parents, children and special friends all shared in our annual Easter egg hunts in preparation for Easter worship.

Throughout the year, CFM hosted and helped to lead Messy Church, a special time of worship filled with music, prayer, a customized message, and activities suited for families. Each Messy Church included dozens of families participating together!





The summer program calendar was highlighted by Vacation Bible School (where an outer space theme and a message of "Shine Jesus' Light" greeted the 50+ children who attended). It was great to see our attendance figures tick back up post-COVID.

In the fall, CFM programming was in full force with back-to-school events, implementation of a new Sunday school curriculum, and an enhanced children's moment at both the 9am and 11am worship services specifically designed to involve our children more deeply in hearing God's word. CFM also piloted a "Children's Church" experience following the children's moment to offer our kindergarteners and 1st graders a customized experience in the gym during the 11am service. CFM also continues to focus on intergenerational interaction, including our very popular bi-annual Bingo nights!







Congregational Care

Trinity's Congregational Care Ministries make God's love visible by offering compassionate care, support, and connection for our members in multiple ways. Members of the Visitation Committee reach out to those who are unable to attend services on a regular basis. Pastors' Aid members are most visible as they provide comfort at memorial service receptions and flowers to those facing sickness or sorrow. Stephen Ministers serve in a confidential role as listeners walking beside those facing daunting challenges. Counseling & Enrichment provides referrals and support of professional counseling as well as church-wide programs supporting mental health.



COUNSELING & ENRICHMENT Roy Simpson & Betts Love

The Counseling & Enrichment (C&E) Committee helps to ensure equitable access to mental health support from providers with whom Trinity has established a relationship. C&E recognizes the widespread need for counseling and seeks to engage younger members and families more effectively. To this end, C&E is exploring options for support and referral that rely on technology, and in 2023, expanded Trinity's formal partnerships to include a broader number of counselors and mental health providers.

The C&E committee includes individuals with expertise in pastoral care and an openness to innovative solutions, such as leveraging QR codes, to broaden access to counseling and spiritual support. The committee's primary goal for 2024 is to expand access to counseling and enrichment support for both individuals and groups in our community.

PASTORS' AID

In 2023, the Pastors' Aid Committee continued to support the families and guests of Trinity Church through many activities. Pastors' Aid regularly:

- Provides receptions following interments and memorial services. A dedicated group of volunteers supports this ministry of hospitality, including bakers who provide treats for these occasions.
- Delivers flowers from Sunday worship to Trinity members during times of sadness and joy.
- Sends birthday cards to celebrate our Trinity members 80 years plus!
- Sends notes of congratulation to new parents.
- Sends notes of bereavement to both Trinity members and their families following the death of a Trinity member.
- Sends notes to Trinity members in retirement and nursing home communities, sharing Trinity news and words of encouragement.



STEPHEN MINISTRY

Trinity's Stephen Ministers provide confidential one-on-one care to our congregation members during times of crisis, isolation, and other life difficulties. In addition, we hold monthly meetings where we provide supervision and continuing education to our compassionate Stephen Ministers, emphasizing their personal growth and connections to each other and their Care Receivers (CRs).

Trinity's Stephen Ministry holds monthly meetings in person, with a total of 27 active Stephen Ministers and leaders. Assigned Stephen Ministers continue to be in touch by phone, email, text, and conducting in-person meetings several times monthly. Stephen Ministers also serve as visitors and have reached out to congregation members as part of the ongoing efforts to extend "church" in new and innovative ways. Trinity Stephen Ministry utilizes a confidential church email address for inquiries and communication. Several caring relationships closed in 2023, as care receivers reached a natural point of stabilization, comfort, and healing. New caring relationships began this year, particularly in the fourth quarter of the year.

Stephen Ministy's 2024 goals include expanding awareness of the program, including enhanced web presence and communication churchwide.

VISITATION

The Visitation ministry is an outreach to Trinity's congregation. At least one visitation partner is connected with those identified by staff and the visitation team as unable to attend worship or share fellowship with our congregation regularly. Volunteers routinely contact 35-40 members through phone calls, notes, and in-person; send Christmas and Easter cards to all contact members; and offer transportation options, Trinity Zoom opportunities and various community resources to committee members and partners. For example, in 2023 the Visitation Ministry offered a short introduction to metro Atlanta services available to the vision impaired. Volunteers also extend the Communion Table to those at home and in retirement homes.

The Congregational Life Committee (CL) creates and supports intergenerational fellowship and engagement at Trinity. In 2023, CL collaborated with others, including the Holy Smokers, to offer churchwide picnics in May and September, marking the end of one school year and the kick-off of the next year. The September Kick-off BBQ was a hugely successful event with over 400 people in attendance, gathered around the table and enjoying being together.

In February, CL helped host the first ever "Trinity's Got Talent" show to a packed Loft space. Under the event leadership of Mary-Elizabeth Jackson, Trinity enjoyed a delightful evening with acts that included singing, playing instruments, dramatic reading, comedy and puzzle solving. It was such a success that CL is planning it again for February 2024.

In the spring, Congregational Life brought the "Swing and Stroll" to Trinity. Catherine Kraft and Olivia Wall chaired the event, celebrating art from our members, jazz from a local group, and refreshments. Swing and Stroll will be on the calendar again in spring 2025.

Congregational Life continued to support other committees including providing food for our Engagement Fair, and the weekly post-worship Punch on the Porch as a time of fellowship among members.

And to close the calendar year, CL provided both the church Advent Devotional and the beautiful holiday decoration all around our church. The devotional was a team effort beginning with the recruitment of writers, led by Molly Jamieson. Many thanks to our editors (and especially Ellie Sullivan) for the layout, coordination with children's art, and other details.

Church decorations at the holidays were overseen by Seale Lindsay, who created a new vision for the entire Trinity campus. CL added four new trees, continued to sell poinsettias, and focused on purchasing Christmas decorations that can be used year after year, including greenery, wreaths, and ilex berries. Finance

The Finance Committee of the Session ensures the fiscal health of Trinity Presbyterian Church, both short- and long-term. The committee is actively engaged in all financial aspects of the church. Members are assigned as liaisons to each other ministry area of the church, and liaisons are available throughout the year to work with their designated ministry areas. This is especially important during the annual budgeting process, by which each ministry builds a draft budget reflecting upcoming needs. The Finance Committee receives these various requests and uses them to create the annual operating budget, which is submitted to Session for approval and adoption.

Trinity's annual commitment campaigns drive the budget and expenses for the upcoming year. Almost 95% of total church income comes from annual gifts of members (pledged and unpledged giving). The remaining 5% of income comes from trust fund income, earned interest, and income generated from building use.

Trinity is financially healthy and well-positioned for the years to come. In addition to the beautiful property and campus, the church has no debt and a fully-funded operational reserve. In 2024, the committee hopes to be able to adopt the budget even earlier in the year and to continue on our two-year trend of increased participation in annual giving and increased revenue.

The 2024 Commitment Campaign–Forward in Faith–kicked off on October 7, 2023, with a goal of \$3,750,000 in pledges and increased participation from the congregation over 2023. Every household in the church received a letter, brochure, and pledge card in the mail and for

the first time, every child and youth in the church received their own separate pledge card, geared to encourage Trinity's young people to think about the time, talent, and treasure they have to share.

The campaign was ably chaired by Melissa Moseley and Stan Tilley, with support from Bonnie Harris, Rebekah LeMon, Heather Edmiston, and Janet Martin. During the month of October, members John Tirrill, David and Christine Quillian, Drew Timmons, Melissa Moseley and Stan Tilley offered personal reflections about their commitment and giving to Trinity as part of our worship services.

The campaign was a great success! It closed on January 31, 2024, with commitments totaling \$3,875,832 from 478 adults/households and 20 children/youth-marked increases in both amounts pledged and overall participation.

Membership & Engagement

Trinity's Membership Committee goals are to (1) welcome new members into the life and work of Trinity, (2) strengthen relationships between Trinity members, and (3) connect current members in the congregational life of Trinity Church. Trinity welcomed 40 new members in 2023 and will continue to build on this growth and rhythm of swelling engagement of all members.

The Membership Committee's 2023 goals included continued focus on organizing and formalizing Discover Trinity, the curriculum and process welcoming new members. New members were welcomed intentionally at several points in their joining process and beyond–at their month of joining, with personal Christmas cards, and at an annual celebration dinner in a member's home.

In the spring, the committee set out to call and connect with every Trinity member by phone to update information and hear feedback and suggestions. 34 volunteers, including committee and Session members, contacted 818 households. 196 entries were updated in our directory. Meaningful conversations and questions emerged. Some requested pastoral calls, some needed help with technological ties to Trinity, and many used the calls as an opportunity to get more involved. The Membership committee intends to repeat this process at least every 3 years.

Membership hosted an engagement fair in the fall to help TPC members see the breadth of engagement opportunities here and get more involved in them. The fair was a wonderful display of the variety of activities and good spirit of the church. Going forward, Membership intends to reimagine this engagement fair, as well as organize opportunities to celebrate the volunteerism that is at the heart of our church.

Mission

In 2023, the Trinity Mission Council focused activities and funding in three primary areas of need: advocacy, education and hunger.

MISSION EVENTS HIGHLIGHTS

- Led a trip to Cuba in February including 15 Trinity members, as well as Rebekah LeMon and Lucy Strong
- Expanded relationship with Living Waters of the World water filtration system in Cuba funded by the Mission Reserve account, planning to add a new system to the town of Matanzas in the near future
- Received from the International Rescue Committee (IRC) its annual Spirit of IRC Award for our work with refugee families
- Worked with IRC to welcome a Myanmar family
- 40 Things in 40 days of Lent: food collection for Meals on Wheels Atlanta (MOWA)
- Added two additional groups delivering meals for MOWA
- Central Presbyterian Sunday Courtyard Ministry: served breakfast to guests experiencing homelessness every fourth Sunday
- Lunch and cold weather bag packing events for guests of the Central Outreach and Advocacy Center
- Donated supplies for the Agape Backpack Bonanza
- Agape Giving Tree: provided gifts for 75 students and 20 seniors, grocery gift cards for 50 families
- Trinity Christmas Market: Over 300 shoppers and 65 volunteers at the 2023 Christmas Market raised more than \$29,000 raised for mission work in Cuba, Haiti, and for refugee resettlement in Atlanta
- Hosted two blood drives in partnership with the American Red Cross
- Prepared for two Adult Education classes concerning Trinity's work addressing hunger, particularly through MOWA, and our work with refugees through IRC

Faith in Action

The Faith In Action Committee's mission is to respond to the call in Micah to "do justice, love mercy and walk humbly with your God" and Jesus' directions to care for the stranger, the poor, the excluded, the imprisoned, and indeed, all of God's creation.

In 2023, members worked toward criminal justice reform in multiple ways:

- Trinity hosted a Record Restriction Day September 23 in partnership with the Fulton County District Attorney's Office and the Georgia Justice Project (GJP). This event helped many individuals meeting certain criteria to have their records sealed, enabling them better access to employment and housing. Esther Stokes led the steering committee; Ginny Hobbs led the job fair with 10 exhibitors who could assist applicants with job contacts and services. Anne Blitch and Jim Gober led the Trinity volunteer lawyers who helped out at the event, and Velma Tilley recruited many volunteers who kept things running smoothly. Other steering committee members were Donna Draughon, Lasley Gober, Paige Keller, and Gina Nana.
- Many members worked with GJP to interview returning citizens at the Metro Re-entry Facility, helping to identify barriers to their re-entry.
- Many Trinity volunteers helped with both the men's and the women's Family Days at the Metro Re-entry Facility, an important event for returning citizens and their families.
 - Exciting news: Trinity was awarded the Sheandra Clark Volunteer of the Year Award from GJP at their Grass Roots Justice event in April.
- Eleven members of FIA attended the End Mass Incarceration conference at Ebenezer Baptist Church in January, and then attended monthly meetings with the End Mass Incarceration Georgia initiative. This participation led to scheduling the Record Restriction Day.
- Adult Education and FIA partnered to present a special Sunday School class focused on the Georgia Corrections System and the need for criminal justice reform in Georgia.

- Advocacy has also been a focus for FIA this year at the state legislature:
- FIA members supported Presbyterians For a Better Georgia (PBG)'s work supporting bipartisan bills related to healthcare and housing.
- FIA members supported Georgia Justice Project's bipartisan efforts to break down barriers to opportunity for individuals impacted by the criminal justice system.
- Teed Poe worked with others to organize a gun safety group. After many discussions, the group chose to work on advocacy at the state level and aligned with the Georgia Majority for Gun Safety, urging passage of the Pediatric Health Safe Storage Act.

Members also sought to address food insecurity in our community. Shannon Sale helped TPC volunteers with the opportunity to pack food boxes for Grady patients and food insecure individuals in the Buford Highway corridor in Brookhaven once per month.


also retired. We are very grateful for their service.

The Property Committee works closely with Trinity staff to oversee the operation and maintenance of all physical aspects of the Trinity property— its buildings, landscapes, and playgrounds. The goal of excellent property management exists to ensure the church property is well-maintained, well-planned, and operated efficiently in order to support the work of all the other committees and ministries at Trinity. A number of significant renovation and upgrades to Trinity's physical plant continued in 2023, including painting and new carpet to greatly enhance the halls and walls of Building D, the Rotunda, etc., continued work on a new security infrastructure and improved audio visual equipment, completion of the exterior and interior signage for the church, new furniture and photos and other art on the walls, and a planned modernization of the elevators. In addition to the work on the buildings, there are constant repairs to aging HVAC systems, drains, and windows as well as enhanced plantings in the Memorial Garden with the new construction next door. The above stated work has been completed with money coming from various sources—the Infrastructure mini campaign conducted to undertake the projects, various trust funds that have been set aside for property purposes, and the Property budget itself. The Property Committee will be working closely with the Finance Committee to ensure that our 2024 budget request is adequate to continue the ongoing projects and have cushion for unforeseen needs that inevitably come with an aging building and grounds. Going forward, the Property Committee will continue to address areas within the facility in need of upgrades and will attempt to do that work over the summer months. Many of the major renovation projects have been completed in the past two years thanks to the great work of prior committee members.

MISSION AND FRAMEWORK

The mission of Trinity Presbyterian Preschool (TPP) is to provide a faith-based education in a safe, family-like environment. We seek to nurture each child's head, hands, and heart by encouraging curiosity, exploration, and learning. The Executive Director and the Director of Curriculum and Finance administer the program and are advised by the Board of Directors. This Board consists of members of current and former preschool parents (including the Parent Council chair) and church members. Additionally, there is one current Session member on the Board. TPP is intentionally small to offer a close-knit environment. Currently, TPP has four classrooms (52 students) and a staff of thirteen educators and administrators.

CURRICULUM AND LEARNING

TPP uses the Creative Curriculum, which builds children's confidence, creativity, and critical thinking skills through hands-on, project-based investigations. Our 3s and Pre-K classes use the Handwriting Without Tears program, introducing letter formation and pencil grip in a developmentally appropriate manner. All students participate in enrichment classes as developmentally appropriate, including music, art, creative movement, science, maker, and library. Each week, students attend chapel with a focus on the fruits of the Spirit. TPP teachers make ample use of the campus' vast outdoor space for play, learning and learning through play! This includes class or reading time in the Children's Exploration Garden, nature walks on the Trinity Trails, class in the courtyard and playground time.

UPDATES AND LOOKING AHEAD

In June, Erin Carey joined TPP as the new Executive Director. She comes to TPP with many years of Early Education experience, a passion for working with teachers and families of young children, and a great appreciation of all the work that came into making TPP what it is today. Summer of 2023 also brought some facility enhancements to Building D, which houses the preschool, including new floors, paint and an overall refresh. During the fall, families enjoyed TPP Bike Night and visited their "scarecrow" at the Atlanta Botanical Garden. In September,

In 2023, the Youth and Family Ministries at Trinity experienced transformative change, marked by resilience, growth, and a deep commitment to mission. Despite uncertainties, the youth group not only maintained regular programming but also expanded its horizons, adding new mission opportunities and enhancing small group connections.

This year, YFM sought to empower and connect youth, emphasizing the importance of service and community involvement. For example, our youth engaged in impactful service with our partners at the Central Outreach and Advocacy Center and Bashor Night Shelter.







The introduction of youth group-wide games, worship sessions, and curriculum tailored to the specific needs of middle and high school participants enhanced the overall Sunday night youth group experience. Relational gatherings are at the heart of youth ministry, and the fall semester saw over 35 new small group meeting opportunities and over 30 successful engagements that highlighted our strong parental and student participation.

The Small Groups initiative flourished, offering 16 weeks of rich discussions in middle school and high school groups. The approach of starting small to foster powerful faith conversations proved successful, with bolstered Leader Training. High school engagement was particularly noteworthy in fall 2023, with consistent attendance of 12-16 high schoolers, evenly split between boys and girls. Middle school engagement remained strong, underscoring the adaptability and continuous improvement evident throughout the fall.

As the ministry eagerly approaches the 2024 spring and summer seasons, the positive momentum from fall initiatives fuels anticipation. Together, Trinity's Youth and Family Ministries are cultivating a thriving environment of fellowship, growth, and shared purpose.

Worship & Music

At Trinity, worship is the heart of our life together. The Worship and Music Ministry Committee and its subcommittees assist the Session and staff in providing and supporting worship that glorifies God and addresses the needs of families and individuals of all ages.

- In 2023, 94 worship services at Trinity were supported by:
- Members of our Usher/Greeter Teams (60)
- The Communion Preparation Committee (10),
- The Flower Guild (26)
- The Chancel Choir Program (140), and our Cherub, Primary, Junior, and Youth Choirs.
- The Wedding Committee (18 members) supported
 7 weddings.
- The Memorial Service Committee (24 members) assisted in 11 memorial services.
- The Memorial Garden Committee (7 members) handled arrangements for 15 interments. The Committee also worked with Jana Rhoden, Oakland Cemetery gardener, on landscape and maintenance of this sacred space.

Worship included weekly Sunday services, as well as special services during Lent, Easter, Advent and Christmas Eve. We welcomed 1,040 inperson + 229 on-line for Easter Sunday and 1,668 in-person + 276 on-line for Christmas Eve!





Early in the year, we shared in moving worship at the installation services of both Rev. Rebekah LeMon and Rev. Lucy Strong. We were also led in worship by our elementary-aged children on Children's Sunday and by middle and high school youth on Youth and Confirmation Sunday.

The summer Congregational Hymn Sing on August 6, led by Rebekah, Lucy and Norman, was an inspirational addition to worship. As part of a carefully crafted liturgy, this service featured 17 hymns drawn from congregational suggestions. The Chancel Choir was interspersed throughout the congregation to form an impressive choir in the pews. Those attending will long remember the sound of "Holy, Holy, Holy" with Chancel Choir members singing the descant, just as they did at both installation services earlier in the year.

In 2023, Trinity also restarted the acolyte program at both 9:00 and 11:00 AM, offering children and youth worship leadership opportunities and the reminder that Christ is the light of the world.

Christmas Eve worship also included the lighting of candles among all worshipers and singing Silent Night together at all four afternoon/ evening services.

Our Music Ministry shared their talents in the following special ways:

- Spring Music Festival, March 26: Schubert: Mass in G with full orchestra
- Music for a Summer Evening, August 13: Works of Brahms, Hahn, Samuel Barber and Benjamin Britten's Canticle of Abraham and Isaac.
- Fall Music Festival, November 19: Songs of Thanks and Praise: Great Choral Works of Mendelssohn, Rachmaninov, and featuring the monumental Coronation Te Deum of Sir William Walton
- Re-establishment of the Westminster Ringers, the adult handbell musicians directed by Scott Morris.
- Congregational Carol Sing, December 17, with almost 200 singing Christmas carols with Norman Mackenzie in a truly intergenerational and joyful event!

The Trinity Presbyterian Trust Fund was incorporated in 1960 to encourage gifts and bequests to enhance the work of Trinity Presbyterian Church and the Presbyterian Church (USA). Since that time a dozen trust funds have been established, some through bequests, some by the Congregation and others through gifts from Trinity members.

There are seven Trustees, with a new Trustee elected by the Session each year for a seven year term. In 2023, the Trustees were: Ann Speer, who completed her term in December; Bonnie Harris, Margaret Reiser, Tom Jones, Frank Fuerst, John Oglesby, and Cindy Ferguson. The Session elected Bill Jordan as a new Trustee starting in 2024. An Investment Committee, made up of Trinity members Richard O'Donnell, John Shepard and Mark Stancil, provides counsel to the Trustees on how to best invest Trust Fund assets.

The Trustees' role is to oversee the Trust Funds and ensure they are invested wisely and that requests meet donor intent. The Trustees encourage planned giving at Trinity and bring a deep commitment to the ongoing success of Trinity and its mission. Requests for distributions come from a Session committee which the Trustees review to confirm the purpose meets donor intent, and then vote to recommend to Session for final approval.

HIGHLIGHTS OF THE YEAR

In 2023, Trinity received memorial gifts of \$38,242 which were added to Trinity's General Trust Fund. Also in 2023, in response to a critical need at Trinity, a new Trust Fund was created: the Kahn Family Fund for Employee Development and Well-Being. The purpose of the Fund is to support Trinity staff and employees in the following areas: Individual Staff Member Development, Ministry Area and Staff Professional Development and Continuing Education, Staff Fellowship and Team Building, Staff Health and Wellness, and Staff Financial Support.

Trust fund distributions in 2023 included support for: sacred furnishings and worship items from the Love Ministry Impact Fund; Agape Youth & Family Center meals from the Brumley-Love-Morell Fund; Kittrell

Lecture expenses from the Kittrell Speakership Fund; the New Church Development Commission's Pastor Cohort from the New Church Development Fund; the Trinity Fellow in Youth Ministry from the Fellows in Ministry Fund; member counseling from the Counseling and Enrichment Fund; and scholarships and cabinet painting from the TELC Fund. In addition, the annual draw from the General and Mission Trust Funds provided support for Trinity's operating and mission budgets, and the annual draw from the Carson Major Maintenance Fund provided support for the property operating reserve at Trinity.

The Trinity Trust has been established for those who have looked beyond this life to make a commitment to Trinity's future and for those who wish to give beyond their unified budget support. These gifts are used to enable Trinity to serve its mission beyond what is possible through our annual Commitment Campaign.

Trinity Early Learning Center continues to be proud covenant partner with Trinity Presbyterian Church. At TELC, we strive to meet our mission statement each and everyday:

- Provide superior, developmentally appropriate, culturally diverse early childhood education and care for children, designed to foster social and emotional growth, cognitive and academic development, and independence and self-esteem.
- · Provide an employment environment for teachers that encourages and supports professional growth.

TELC is focused on attracting and retaining high quality teachers to guide our children's development. With funds provided through TPC's Trinity Early Learning Center Trust, TELC is grateful to be able to offer a tuition reimbursement program for approved education courses for teachers to continue their professional education. Through this program, TELC has been a catalyst in helping employees' growth in the early childhood profession from earning their initial CDA up to earning BA and Masters degrees.

TELC is a licensed childcare program via Bright from the Start, Dept. of Early Care and Learning in the state of Georgia. TELC strives to go above and beyond to provide a quality program. We understand that accreditation programs are an important piece to the quality puzzle. As a result, TELC continues it's relationship and accreditation status with the National Association for the Education of Young Children (NAEYC). Toward the end of 2023, TELC set the groundwork to earn our Quality Rating through the state of Georgia. Our center visit/observation is the pipeline for early in second quarter of 2024

Parent partnerships are key to any early childhood program, and TELC feels this to be a cornerstone of its program. The Center's continued investment in the electronic communication tool, KAYMBU, proves to be a game changer in our ability to communicate directly with families through-out the day. Through the app, the teaching staff is also able to track a child's development and create electronic portfolio of their development. These portfolios prove instrumental during Parent/ Teacher Conferences helping families understand their child's learning. While Kaymbu continues to be an invaluable resource for day to day connections with parents, it's ability to connect and share with extended family members so they can see the growth and learning from far away is priceless.

One of TELC's biggest events, Miles for Smiles, has evolved from a 5K run event into a field day event for children and families. This new format has shown to be a huge success while allowing the event to continue be a viable fundraiser as an integral component to the our scholarship fund.

Through the gracious support and partnership that TELC has with Trinity Presbyterian Church, coupled with the creative, dedicated teaching staff, continue to place TELC as a leader in the Atlanta early childhood education industry.
